8. Council Biodiversity Action Plan.

The council will look to work with the village hall, playing field and woodland area. The clerk advised she will be attending a talk for parish councils on biodiversity and will report to council at next meeting.

9. Consultations.

9.1. Norfolk County Councils proposed changes to street lighting across the county.

This will affect streetlights on the A146 Thurton Norwich Road, between the Avenues and Vale Road, along with Norwich Road lights approaching from Norwich. The council concerned as the road was upgraded as dangerous and there were concerns about the accident rates. Council to respond to consultation accordingly.

10. A146 Speed awareness Campaign

Standing orders stood down to enable member of the public to speak.

Member of the public spoke of concerns around pollution and if the speed of vehicles is reduced, this could increase carbon monoxide, which would be detrimental to health. Speed limits need to be reviewed in particular Hellington Corner.

Standing orders reinstated.

Chairman spoke of an improvement to the junction with the Street and Norwich Road. The crossing island, which is too small for the A146 and puts pedestrians in a dangerous position as it is too close to passing traffic. Concerns around what cables/pipework i.e., water, telephone and gas are installed within this area and could this rule out any changes. A speed limit change would help but the road needs to be widened to give a bigger safety island. The road would also benefit from the installation of safety kerbs on the approach from Norwich and Loddon. CP also asked whether a footpath could be constructed from Prospect Place to the centre of Thurton to enable people to walk down to the village without having to cross the road, where this a footpath.

11. Emergency Plan

Responses have been received from thirty-eight properties. MR will oversee the plan in electronic format.

12. Report from representative of Village Hall Management Committee.

CP advised that she should soon hear if they were successful in obtaining a Pride in Place grant from South Norfolk.

Still corresponding with the Land Registry who had lost the original application. Advised that the officer assigned to the case had not fully investigated. A departmental lawyer is now involved, and an absolute title should have been granted.

It has been agreed that the village hall hire charges will be increased. The cost to the parish council will remain the same.

1.2 What are play streets?

Play streets (or 'playing out' sessions) are neighbour-led, short, road closures, creating a safe space for children to play freely together on their doorstep. Any street is eligible provided it is not on an active bus route. Play streets typically allow children to play freely, without organised games or activities. In practice, this means children cycle, scoot, skate, chalk, skip, hopscotch, kick a ball around and make up games.

This model was first developed by parents on one street in <u>Bristol in 2009</u> and has now been taken up by hundreds of street communities all over the UK.

The key features of this model are:

- Resident-led and organised.
- Short, regular road closures
- Free, child-led play
- All neighbours consulted and included.
- Road legally and safely closed to through traffic.
- Stewarded by residents.
- Car access at walking pace
- Simple, 'normal' not a street party!
